Citation and commencement.	1. This Law may be cited as the Appropriation (Review) Law, 2020 and shall come into force on the3.0.7.4day of
Interpretation.	2. In this Law, unless the context requires:-
	"Principal Law" means the Appropriation Law, 2020.
Reviewed.	3(1) The Appropriation Law, 2020 is hereby reviewed due to the Corona Virus Pandemic.
	(2) The Funds Appropriated under the Appropriation Law, 2020 shall be reviewed, the Capital and Recurrent Expenditure amounts appropriated under the Principal Law shall be changed as specified in the Schedules I and II attached.
Period.	4. The Appropriation (Review) made under this Law shall be for the period beginning on the 1 <sup>st</sup> day of January, 2020 and ending on the 31 <sup>st</sup> day of December, 2020.

Authorized expenditure.

5. The Accountant General of Kebbi State may on a Warrant signed by the Commissioner responsible for Finance, issue from the Consolidated Revenue Funds of Kebbi State during the financial year beginning from 1<sup>st</sup> day of January, 2020 and ending 31<sup>st</sup> day of December, 2020, a sum of *Ninety-Nine Billion, Six Hundred and Eighty-Three Million, Six Hundred and Ninety Thousand, and Fifteen Naira only* being the total of the amount set forth opposite the Heads specified in the Schedules hereto.

Appropriation of N99,683,690,015

6. The sum of Ninety-Nine Billion, Six Hundred and Eighty-Three Million, Six Hundred and Ninety Thousand, and Fifteen Naira only is hereby appropriated for the purposes of the expenditure set forth opposite the respective Heads specified in the Schedules hereto.
