EXECUTIVE ORDER NO. CC (2020)05 OF 2020


BY THE GOVERNOR OF KEBBI STATE ON FULFILLMENT OF PARTICIATION CRITERIA FOR ACCESSING TECHNICAL ASSISATNCE BY THE WORLD BANK FOR THE SFTAS NEW DISBURSEMENT LINKED INDICATOR (DLI) 5

1. WHEREAS, Kebbi State Government is desirous of participating in technical assistance to be provided by the world bank for the New Disbursement Linked Indicator (DLI) 5 of the State's Fiscal, Transparency, Accountability and Sustainability Program;
2. WHEREAS, the Kebbi State Government is keen to improve efficiency in discharging government business by introducing measures that enhance the transparency standard in Government expenditure and management of projects under SFTAS DLI 5 hereby constitutes the following as steering committee to achieve the SFTAS New DLI5
 - a) Commissioner of Lands and Housing
 - b) Commissioner of Budget and Planning
 - c) Commissioner of Information and Communication Technology
 - d) Permanent Secretary Ministry of Lands and Housing
 - e) Permanent Secretary Ministry of Finance
 - f) Permanent Secretary Ministry of Budget and Economic Planning
 - g) Chairman Board of Internal Revenue
 - h) General Manager, Kebbi Urban Development Authority
 - i) General Manager, Housing Corporation
 - j) Special Adviser, Office of the Governor
 - k) Surveyor General of Kebbi State
3. WHEREAS the terms of Reference of the Steering Committee are as follows
 - a) advise the Governor on the most effective way of achieving the project goal (and receiving the associated resources) by approving a work plan for field data collection and making resources available for implementation (as prepared by the State Project Manager);
 - b) identify the agency responsible for hosting and sharing of data provided by the World Bank TA associated with the project and report on use cases that demonstrate the associated potential;

- c) oversee implementation of field enumeration to achieve the DLI and resolving any issues that may require attention; and
 - d) recommend ways to make the most effective use of data, based on documented progress and analysis of data on owners/occupiers collected to meet the DLI as well as complementary ones available at the State level. Also use same to identify resources for supporting associated additional activities and document the impact of doing so.
4. WHEREAS Bashiru Saidu Bakuwai is hereby appointed as a full-time State Project Manager (SPM) for a period of 12 months to coordinate all aspects of implementing the State's efforts to acquire additional data needed to achieve the new DLI 5 under the world bank supported SFTAS program and make effective use of the TA resources provided to the state in this context
5. WHEREAS the Ministry of Lands and Housing is hereby appointed as Agency to implement this project and provide it with the resources needed to
- a) Host the data to be provided by the SFTAS TA project for achieving DLI 5
 - b) Provide the information technology to collect additional parcel and building attributes required for DLI 5 and maintain the web-based dashboard
 - c) Freely share the full data set with other government agencies and public in real time
 - d) Undertake any activities needed to expand their quality and usefulness to the state
 - e) Host and maintain this data infrastructure for 5 years in a way that would ensure continued access by other Government Agencies
6. WHEREAS The Ministry of Lands and Housing is hereby mandated by this Executive Order to host the data made available to the State as part of the SFTAS TA as well as the field data to be collected to achieve DLI 5 under the programme. It is guaranteed that the Ministry has or will receive sufficient capacity to
- a) Host and maintain a for 5 years and in any way that would ensure free, continued access by other Government Agencies the data provided by the SFTAS program TA for New DLI 5. This includes data of buildings and trees as well as 2D vector data of infrastructure and land cover together with building and parcel attributes collected to achieve DLI 5;
 - b) Create, host and update a public web portal
 - c) Support activities needed to expand the usefulness of these data for revenue collection and land management by the State as directed by the Governor or other relevant authorities
 - d) Provide the IT support for collecting and integrating the additional information on buildings and parcels collected by enumerators and required for achieving the DLI, including maintenance of a project management dashboard to report progress with data collection in real time.

7. This Executive Order Shall take effect immediately



- Appointed a full-time Project Manager for 12 months, provided with the resources needed, to execute the project according to the attached Terms of Reference (Annex 2) CC(2020)05
- Appointed by executive order No ___ 2020. , Ministry of Land and Housing as the agency to implement this project and provided it with the resources needed to (i) host the data to be provided by the SFTAS Technical Assistance (TA) project for achieving DLI 5; (ii) provide the Information Technology (IT) to collect additional parcel and building attributes required for DLI 5 and maintain the web-based project dashboard (iii) freely share the full data set with other Government agencies and the public in real time (including through a public web portal), (iv) undertake any activities needed to expand their quality and usefulness to the State and (v) host and maintain this data infrastructure for 5 years in a way that would ensure continued access by other Government agencies (see terms of reference agency in annex 3)
- Provided/authorized resources for tablet-based field enumerations of the additional parcel and building attributes required to meet the DLI using low-cost methods.

Further, I hereby state my commitment to make an anonymized version of the building and parcel attributes data freely available to the World Bank, for analysis and reporting, as well as for possible follow-on projects.
