	• Site Analysis Report SAR prepared by consultants with a clear satellite image, sealed, stamped, and endorsed by a Town Planning Registration Council (TOPREC) registered town planner (for all developments)
	• One hard copy & soft copy of A <sub>3</sub> sized mechanical/electrical working drawings and details, sealed, stamped, and endorsed by a Council for the Regulation of Engineering in Nigeria (COREN) registered Mechanical & Electrical engineer (for all developments). Visit <u>https://portal.coren.gov.ng/account/membersearch</u> to confirm engineer registration status.
