

GUIDELINES FOR OBTAINING A CERTIFICATE OF OCCUPANCY FOR DIRECT LAND ACQUSITION

Guiding Laws & Regulation

In pursuant of the provisions of the Law Establishing Kebbi State Geographic Information System Agency and for other matters connected therewith, Law 002, 2022.

Kebbi State Land Use Regulations, 2022

All individuals and organizations seeking to obtain Certificate of Occupancy (CofO) in Kebbi State can apply through the following process;

Step 1

Using any of the channels below

Obtain the Certificate of Occupancy (CofO) Application form for free for Individual & Organization from;

Step 2

Prepare all relevant documents.

To process your application for acquiring residential, commercial, industrial land, the following documents are required:

- Two passport size photographs of the applicant (Residential & Individual Commercial only)
- Photo Identification: National ID Card or International Passport or Drivers License or Voter's Card
- Current personal income tax clearance certificate OR Visit/contact https://irs.kb.gov.ng/etax/ for TCC and TIN.
- Certificate of Incorporation is required CAC (Corporate bodies)
- An accepted feasibility study (Commercial & Industrial)
- Copy of Memorandum and Articles of Association of the company (in the case of corporate bodies) among other conditions.
- Current Utility bill
- Statutory Right of Occupancy Certificate (certificate must not be older than six months) (https://kebbistate.gov.ng/sites/default/files/GUIDELINES%200F%200BTAINING%20RofO%20%281%29.pdf)
- Court Affidavit of Police Report in the case of lost/stolen documents

Submission of Land Acquisition Application Form Manual Submission

- Pay the applicable processing fee & charges as shown in the link,
 https://kebbistate.gov.ng/sites/default/files/KEBGIS%20LAND%20ACQUISITION%20FEES%20AND%20CHARGES.pdf using any of the available payment channels:
 - Any Commercial Bank in the State using the TSA KEBBI PAYDIRECT account.
 - Via PoS using a debit/credit card located at the State Board of Internal Revenue (SBIR) Customer Service Centre within the KEBGIS Head Office located at No 5, Off Umar Kaoje Road, Gesse Phase II, Birnin Kebbi.
- Submit the duly completed Application Form directly to;
 - KEBGIS No. 5 Off Umar Kaoje Road, Gesse Phase II, Birnin Kebbi together with the following documents;
 - Evidence/proof of payment of application processing fee
 - All applicable documents detailed in Step 2 above.
- Make payment using TSA Online payment platform via https://login.remita.net/remita/onepage/G0000308016/biller.spa

Confirmation of Application:

**Upon Submission of your application, applicants will be provided a unique Application Reference Number and an Acknowledgement Letter that carries the Service Level Agreement (SLA) and file number of the application by KEBGIS.

Processing Timeline

O Submitted applications will be processed **within 30 Working Days** prior to the final stage for collection described in step 4 below.

Step 4

Collection of Statutory Certificate of Occupancy (C of O) Certificate

- Successful applicants will be notified via text, call or email within 60 days to pay applicable charges.
- Upon the Governor's approval, successful applicants will receive an Offer Letter (R of O), an Acceptance Letter containing a Service Level Agreement (SLA) and an invoice for the final bill (Registration charges, document search fees, non-refundable development fee, survey, planning fees, etc.,) as specified in the Schedule of payment of the Kebbi State Land Use Regulations 31-48

- S.pdf
 Payment can be made through any Commercial bank, into the TSA PAY DIRECT account or through SBIR designated
- (PoS) terminal located at KEBGIS (No. 5 Off Umar Kaoje Road, Gesse Phase II, Birnin Kebbi) or online via SBIR website: https://login.remita.net/remita/onepage/G0000308016/biller.spa
- Return signed Acceptance Letter with evidence of payment of all fees to KEBGIS (No. 5 Off Umar Kaoje Road, Gesse Phase II, Birnin Kebbi)
- Successful applicants will be notified within 30 working days via phone call or e-mail to collect their Certificate of Occupancy (C of O).
- Collection shall be at the KEBGIS Head Office at No. 5 Off Umar Kaoje Road, Gesse Phase II, Birnin Kebbi
