- Site Analysis Report (SAR)
- Current personal income tax clearance certificate OR Visit/contact <u>Kebbi State Harmonized E-Tax Portal</u> (kb.gov.ng) for TCC and TIN.
- Certificate of Incorporation is required in the case of corporate bodies
- An accepted feasibility study
- Copy of Memorandum and Articles of Association of the company (in the case of corporate bodies) among other conditions.

Manual Submission

Collection of Right of Way (R of W) Certificate

- Successful applicants are notified via text, call or email within 5-10 working days.
- Successful applicants will receive an Offer Letter of (R of W), an invoice for the final bill and an Acceptance Letter indicating the Service Level Agreement SLA.
- Return signed Acceptance Letter with evidence of payment of all fees to KUDA at Haliru Abdu Road, Near Kofa Sabuwa, Birnin Kebbi
- All successful applicants will be notified within 12 working days via phone call or e-mail to collect their Right of Way (C of O) Certificate. Collection shall be at the KUDA Head Office at Haliru Abdu Road, Near Kofa Sabuwa Roundabout, Birnin Kebbi
