PROCEDURE FOR OBTAINING BUSINESS PREMISE PERMIT

Guiding Laws & Regulation

In pursuant of the provisions of the Kebbi State Registration of Business Premises Law 2014 &

The Administration and Collection of Revenue Due to the Kebbi State Government and Local Government Council Law, 2023

All individuals and organizations seeking to obtain Business Premise Permit in Kebbi State can apply through the following process;

STEP 1: Start your registration by obtaining registration form at any of the offices listed below:

STEP 2: Prepare all relevant documents.

To process your application for BPP the following documents are required:

- Corporate Affairs Commission (CAC) Registration Certificate (**For small, Medium and Large firms**)
- A Certificate of Business Registration (**for micro businesses**)
- Tax Clearance Certificate (TCC) and Tax Identification Number [TIN] (for all forms of business).

STEP 3: Pay applicable fees

- PoS using a debit/credit card at the Customer Service Centre desk in the Ministry of Commerce, Industry, Cooperatives located on the 2nd Floor Gwawangaji Secretariat Complex Birnin Kebbi OR at any Zonal Offices shown in Step 1 above.

STEP 4: Submit all relevant documents

All duly completed application form(s), relevant documents listed in Step 2, as well as evidence/proof of payment of fees and charges should be submitted at the Customer Service Centre desk of the Ministry of Commerce, Industry, and Cooperatives & Tourism located on the 2nd Floor Gwawangaji Secretariat Complex Birnin Kebbi.

**Upon Submission of your application form, applicants will be provided a unique Application Reference Number and an Acknowledgement Letter that carries the file number for the application

STEP 5: Approval and issuance of Business Premises Permit (BPP)

Submitted applications for business premises permits will be processed **within 48 hours** and applicants will be notified within the same timeline to collect BPP permit
